Vendor Application Guidelines

Application Submission

Conditions

- Enrolled Swinomish Members will be given first priority.
- All applications must be completed with signature, photocopy of enrollment/status card, copy of Canoe Registration and payment.
- Applicant agrees to abide by all rules, regulations, and codes established by the Swinomish Tribal Canoe Journey Committee, Swinomish Tribe and other applicable entities.
- **Hours of operation will be from 10 a.m. to 10 p.m. Set-up permitted one day prior to event.**
- Vendors who remain on the premises after the 1-week period will be charged an additional fee of \$100.00 per day.
- Applicants are responsible for providing their own tents, canopies, tables, chairs, skirting, power, water, etc.
- No selling of: play ink, invisible ink, spray string, "fart spray", confetti popper, candy cigars/cigarettes, play lighters or "pop it bags".
- Swinomish Tribal Canoe Journey Committee has the right to deny any vendor application if deemed unacceptable.
- Food vendors will only be allowed in the designated food vendor area. Non-food vendors will only be allowed in the non-food vendor area. **There is absolutely no combination of General/Food Vendor Spaces.**
- The Swinomish Tribal Canoe Journeys Committee will not grant exclusivity of any product.

- **Cancellation of Vendor Space after July 10, 2011 will result in forfeiture of all fees paid.**
- Review of temporary food service establishment Vendor applications is based on the proposed menu, proposed method of food preparation, and compliance with the 2009 FDA Food Code. **Food preparation procedures must be in compliance with the Paddle to Swinomish Tribal Journey 2011 Health and Sanitation Policy.** If your application is approved, a temporary food service permit will be issued. The permit is specific to the menu and facility on your application. It is important that you serve only foods that are specified on your permit. **All menu changes must be approved by the Indian Health Board before the event begins.** The risk of food poisoning is always present, but can be reduced or eliminated by following the Paddle to Swinomish Tribal Journey 2011 Health and Sanitation Policy. Our primary goal is to help you provide safe food to those attending your event. Vendor Spaces

- **Space size will be 10'x10' with fees as noted above for the entire week.**
- If you require more than the provided space, you will need to pay an additional matching fee for each additional 10'x10' space.
- Tribal Canoe Families who have completed the registration for their Canoe Society will be given second priority. Canoe Society Families who have not registered will not be given priority and will be required to pay the full price of \$400.00.
- Electricity, running water & lights will not be provided.
- Any attempt to connect to Tribal facilities will result in forfeiture of space and all fees paid.
- Generators are permitted but not provided.

Security

- The Swinomish Indian Tribal Community and the Swinomish Tribal Canoe Journey Committee will not be responsible for any lost, stolen or damaged property of the Vendor.
- Swinomish Public Safety will be present during the event. If there is a need to contact the Swinomish PD, you may contact them at 360-466-7244.

VENDOR AGREEMENT AND RELEASE

In return for approval of my vendor application, I agree to the following:

1) I will comply with the above Guidelines, the **Swinomish Tribal Journey 2011 Health & Sanitation Policy, available at [website]**, all applicable laws, rules and regulations of the Swinomish Indian Tribal Community ("Tribe"), and the rules and directives of the Swinomish Tribal Canoe Journey Committee. I understand that failure to comply may result in the forfeiture of my vendor status and space and of any fees already paid.

2) I agree to assume all responsibility for my activities as a vendor, including the activities of my employees and agents, and to assume all risk of loss or injury to myself, my property, my employees and agents, and any other person or property that result in whole or in part from my activities as a vendor.

3) I release and agree to hold harmless and indemnify the Tribe, the Swinomish Tribal Canoe Journey Committee and the officers, agents, employees and volunteers of the Tribe or Committee, from

all suits, claims or liability of any nature on account of injuries or damages sustained by any person or property resulting in whole or in part from my activities as a vendor.

4) I intend and agree that this Vendor Agreement and Release is legally binding on me, my heirs, assigns, successors, personal representatives and executors.
